Basic Services of Funeral Director and Staff: \$ 375.00

Our fee for the Services of the Funeral Director and Staff includes, but is not limited to, staff to respond to initial request for services, preparation and filing of necessary authorization and permits, recording vital statistics, placement of obituary notice on our website, staff assistance prior to, during, and following the cremation. Also included in these charges are overhead expenses relative to our facility such as insurance, maintenance, utility expenses, secretarial, and administrative costs. This fee for our basic services and overhead will be added to the total cost of the arrangements you select. ☑

Embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.
